

Proposed Commissioner for Older People (Scotland) Bill

Introduction

A draft proposal for a Bill to establish an independent Commissioner to promote and safeguard the rights and interests of older people.

The consultation runs from 13 June to 23 October 2023 (previously 12 September 2023)

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker.
